

Privacy Notice

Under provisions in force in the Federal Law for the Protection of Personal Data Held by Individuals, published in Federal Official Bulletin dated July 5, 2010 (hereinafter, the "Law"), we inform the person who holds the personal data (the "Holder") that some of the personal information (the "Personal Data") he/she may provide us, whether in person or directly through any electronic, optic, sound, visual medium, or through any other technology or by any other means during his/her interactions with us, may be collected and saved by us with the sole purpose of providing legal services, as well as to correctly identify the Holder in our systems and deliver to him/her communications related to the purpose of this notice, perform the corresponding invoicing, and formalize in agreements or other legal or other documents, the relationship between the Holder and us or third parties originated in the purpose of this notice.

On occasion, the Personal Data will be transferred to our affiliated companies or to corporations providing us services related to the purpose of use of Personal Data provided in this notice.

With respect to the Personal Data we collect, we undertake to give the same the treatment necessary to achieve the ends mentioned in this notice, and as a consequence of the legal services provided by our firm to the Holder, and to treat such data in the same matter as common practices to protect the confidentiality of the same.

Access to the Holders' Personal Data is limited to those persons who need to have access or who is convenient to give access to the Personal Data to achieve the ends of the use of such information provided in this notice. Although we use the precautions sufficient to protect your Personal Data, we are unable to guarantee absolute security.
